Re: Accreditation Decision - Programme

Dear Stefanos and Danae,

The ECTE Accreditation Commission (AC) in its session on May 17, 2022, granted programme re-accreditation with requirements to Greek Bible College for

Πιστοποιητικό Σπουδών (Certificate of Study) at EQF Level 6 with 180 ECTS-points.

This programme is comparable to ISCED level 6 – category 64 (research-oriented). It is referenced in the ICETE framework as “Bachelor” (see [ECTE Accreditation Directory](#)).

This programme re-accreditation decision is based on the report submitted by the Review Secretary in February 2022 after the on-site visit in December 2021 and additional representation provided by GBC for the May 17, 2022, session of the Commission.

The wording of the following **requirement** has been aligned by the AC with the relevant ECTE Standard.

Requirement related to Standard B.4.3:

Establish a policy related to recognition of transfer credits and publish appropriately. This policy needs to be clear, fit-for-purpose, public and applied consistently.

Documentation of fulfilment of this requirement can be achieved by submitting to the AC the approved and published policy at any time but **no later than** June 30, 2022, for the Commission to evaluate compliance in its next session

Please see the Review Report for commendations and recommendations issued by the Visiting Evaluation Team and confirmed by the Accreditation Commission. The Accreditation Commission requests that responses to recommendations be included in the Annual Progress Reports (APR's).

The institution and the programmes will be listed as “under review” on the ECTE website until compliance has been ascertained by the Accreditation Commission.


Please publish the following on your website under the heading 'accreditation':
